

Letter From the Director



In 2021, Writers SA represented more writers than ever before to platform the diversity and excellence of SA literary culture. Our membership grew, we provided more free events, and we welcomed new artistic partners.

Most notably, this year we began our expansion into regional South Australia, with the appointment of Alysha Herrmann to Statewide Regional Manager overseeing three regional locations of operations. Supported by RISE and Arts South Australia, this project will see literary activities all across the state and has allowed Writers SA to become truly statewide.

Context Writers Festival was the artistic highlight of the year, with headline guest Professor Aileen Moreton-Robinson. We welcomed guest curator Dominic Guerrera, a Ngarrindjeri and Kaurna poet and artist, who

programmed a stellar lineup of predominantly First Nations writers, journalists and academics to present new conversations on justice and truth. Held over one big weekend at Adelaide City Library, this entirely free event was presented in partnership with City of Adelaide.

With the support of Aesop Foundation, we presented the second iteration of the Deaf Writers project, with the showcase event See Me Through My Hands at Adelaide Writers Week. The SA First Nations Writers Group continued to grow in terms of membership and activity. With the support of the Australia Council for the Arts and Arts South Australia, the group hosted monthly gatherings with high profile Aboriginal and Torres Strait Islander writers, publishers and artists. Writers SA also presented the all-First Nations poetry performance First Words at Adelaide Writers Week.

It was a thrill to welcome new programming partners Nature Festival to present a keynote address with City of Trees author Sophie Cunningham, and a series of free talks and workshops for City of Charles Sturt with author Karen Wyld, poet Manuela Akot, and many others. We added a new intensive workshop program to our roster, with the acclaimed nonfiction writer Kate Holden hosting the five-month Memoir Academy, in addition to First Draft with Sean Williams, and Manuscript Incubator with Victoria Purman.

The members are the beating heart of Writers SA, and it was a pleasure to celebrate your successes in our Monthly Milestone newsletter. The incredible volume of new South Australian works created throughout the year is testament to the vitality of our literary sector.

Writers SA team of staff continued to be extraordinarily adaptive, thoughtful and responsive in the many challenges that Covid-19 presented, and I take pride in the care that we showed for each other and our community of members.

We continued to advocate for the literature and the arts, collaborating with the national literary sector in consultations for the Stella Prize and in regular meetings with the National Writers Centre Network and the First Nations of Australia Writers Network. My thanks to all who've walked with us in 2021 – we look to a bright next year of writing.


Our Objectives and Activities

MEMBERSHIP

It was wonderful to see our membership significantly grow in 2021 with members from all around Australia registering for workshops, member services and complimentary career or industry consultations. We also changed CMS databases (from Kepla to CIVI) and upgraded our event booking system which has streamlined reporting and given us far more accurate and useful membership data. Writers SA is proud to boast members from every state in Australia, and internationally.

Total number of members: 556 full members, 237 concession members, 13 writing groups

New members: 142 new full members, 58 new concession members, 4 new writing groups



MEMBER SERVICES

In 2021 the number of member services we delivered increased across the board. We were able to employ 52 assessors and mentors for a touch under 2 million words and 246 mentorship hours for both members and non-members.

Manuscript Assessments: Writers SA offers writers access to a professional, independent reading and assessment service. All our assessors are industry professionals, with many years' experience in reading, assessing, reviewing, representing and publishing manuscripts. In 2021 we undertook 2 x submissions packages, 2 x paid first feedbacks and 30 x manuscript assessments at approximately 1,895,885 words.

Consultations: We offer complimentary advisory consultations for members who have writing, publishing and creative career queries. These meetings can be conducted in person, over the phone, or video conference, and are a special members-only resource. Full, paid consultations are also available to both members and non-members at tiered prices, with a discount for members. In 2021 there were 56 consults both paid and free.

Mentorships: The Writers SA mentorship program is designed to connect our members with a suitable, formal mentor, at any stage of their writing careers. From writing craft, editing, pre-publication, to marketing and publicity mentorships – and encompassing a wide range of genres – Writers SA assists early-career writers to find the mentor to guide their creativity to the next level. In 2021, we delivered 22 x mentorships equalling 246 hours.



2021 saw just as many Covid-related hurdles tossed at us as 2020, but with the pivot to online workshops already made, we were able to reach participants in SA, interstate and even overseas. Our Writers' Week Masterclasses attracted 60 participants both in-person and online, and we were able to hold one of those sessions at the beautiful Parwana Kitchen with Durkhanai Ayubi. 48 authors and artists delivered 58 workshops and talks, and 4 long-term programs over the year with 1368 participants. We programmed and delivered 2 writers' festivals and a number of free events both for Writers SA and for local councils.

REGIONAL PROGRAM

With the support of Restart Investment to Sustain and Expand (RISE) Fund – an Australian Government initiative, and Arts South Australia, Writers SA initiated the No Limits: Young Regional Writers project in 2021. No Limits saw our staff team grow with the addition of Regional Coordinators in three locations: Riverland, Eyre Peninsula and Limestone Coast. The team began the slow and deliberate process of ongoing consultation to inform relevant and meaningful regional outcomes with a focus on young writers. Consultation began with surveys, in-school conversations, in-person and online workshops, gatherings and other conversations with young people and regional stakeholders. Over quarter four, the regional team began introducing the project through targeted in-person and online gatherings, and laid the groundwork for a series of commissions, special projects and other activities in 2022.

Literary Sector Development

Writers SA continued to develop a diverse and flourishing literary community through our work with targeted groups. Through our advocacy and artist capacity building projects, we provide skills-based and community-led programs to create connections, pathways to industry, interstate collaboration and introductions, and new literary works.

FIRST NATIONS WRITERS

Writers SA supports the SA First Nations Writers Group through collaboration, administrative assistance, and through auspicing and working together on grant-funded projects. With investment from both Australia Council for the Arts and Arts South Australia, 2021 saw great growth, deep engagement, and increased activity for the group.

We opened the year with First Words at the Adelaide Writers Festival – an all-star poetry reading featuring leading First Nations poets from South Australia including Mandy Brown, Ali Cobby Eckermann, Natalie Harkin, Dominic Guerrera, Steven Pappin, Celestine Rowe, and MC Edoardo Crismani.

Throughout the year, the group hosted guest presentations from established authors, playwrights, dramaturgs, poets, film story executives, screenwriters, academics, publishers, media trainers, and members of the Arts

DEAF WRITERS

With the continued support of Aesop Foundation, Writers SA presented the second iteration of See Me Through My Hands, a creative development and mentorship program with emerging writers from the Deaf community. After six months of one-on-one mentorship, the project culminated in an incredible event at Adelaide Writers Week. Samantha Wilson, Sophia Borick and Kate Frost told powerful and artistically rich stories in Auslan, and were joined on stage for a conversation on the creative process and Deaf culture with mentors Stuart Anderson, Joanna Agius OAM, and Debra Swann.

In 2021, the group conducted evaluation and planning for future years of the project with an increase in funding confirmed for 2022.

SOUL LOUNGE

Writers SA supports the monthly poetry event and community Soul Lounge, assisting the group of diverse, emerging poets with financial support to pay featured poets at each event. Held on the last Sunday of every month, Soul Lounge offers an inclusive, alcohol-free, judgement-free space for poets and an open mic. Covid-19 caused the cancellation of Writers SA-supported interstate exchanges, however the group experimented with digital events to great success, and travel will resume in 2022.

LIMINAL

In 2021, Writers SA began a new partnership with Liminal Magazine to produce a digital chapbook of new works of fiction and non-fiction from both emerging and established Asian-Australian writers who live in South Australia. Selected works responding to the theme of Haunt in our 2021 call-out will be published in a collection of Asian-Australian excellence that sees Liminal's first South Australian series, to be published in 2022. Alongside these commissions, Liminal will facilitate a mentorship for two emerging editors, who will work with editors Cher Tan and Elizabeth Flux for hands-on experience editing our South Australian series.

NATIONAL WRITERS CENTRE NETWORK

Writers SA's Director Jessica Alice facilitates the quarterly online meetings of the National Writers Centre Network, composed of our counterparts in each state and territory – ACT Writers, Writers Victoria, Writing WA, NT Writers Centre, TasWriters, Writing NSW and Queensland Writers Centre. At these meetings, we regularly share successes and challenges, sector trends and insights, advocacy activities and national benchmarking of program and membership data. The Network collaborates on national and interstate literary projects, and speaks as a united voice on policy issues relating to literature and publishing.

READERS AND WRITERS IN RESIDENCY PROJECT

2020 saw the postponement of the ongoing Readers and Writers in Residence project which was due to wind up in 2020. Because of the Covid challenges, we were able to hold over the funding for 2021 and sent four authors out into the regions. Tracy Crisp visited the Copper Coast and spent time at Kadina and Port Pirie libraries. Rachael Mead spent time on Kangaroo Island and we'd like to thank Darry Fraser and Alice Teasdale of Big Quince Print for supporting the events. Poet Kami McInnes travelled to the South East and held events at Mt Burr General Store, Millicent Library Civic Centre, Robe Town Brewery and Beyond Words Bookshop. Danielle Clode travelled inland to Coober Pedy and surrounds and held workshops talking about books and fossils at schools, museums and libraries.

PROGRAMMING PARTNERSHIPS

Much of the creative programming we present outside of our own offerings is in partnership with other arts organisations, councils and venues which allows us more scope to meet the specifics needs of the varying demographics across rural and metropolitan South Australia. We're able to raise the platforms of newer authors and present some of the niche topics that don't always suit our own membership. Venue partners are integral to our core business and we appreciate the ongoing support they provide us.

City of Adelaide

Adelaide City Library: Context Writers' Festival is one of the largest projects on our calendar and 2021 saw us bring on guest curator and First Nations author and performer, Dominic Guerrera. Modelled on

the success of the inaugural festival, Dominic programmed, contracted speakers, and delivered a three day free writers' festival in the heart of Adelaide even despite Covid capacity limitations and travel restrictions, with the notable attendance of Professor Aileen Moreton-Robinson. More than 50% of the program featured First Nations artists, culturally diverse artists, queer artists, and artists who live with a disability.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The members of the Board have prepared the financial statements on the basis that the Entity is non-reporting because there are no users dependent on a general purpose financial report. The financial report is therefore a special purpose financial report that has been prepared in order to meet the requirements of the Associations Incorporation Act 1995 and the Australian Charities and Not-for-Profits Commission Acr 2012.

The financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and and interpretations and disclosure requirements of the following standards:

The financial Statements have been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

Revenue Recognition

Revenue is recognised to the extent that it is probable that the economic benefit will flow to the Entity and the revenue can be reliably measured. The following specific recognition criteria must alos be met before revenue is recognised:

Grant Revenue

Revenue from grant funding is recognised when the Entity gains control of the grant or the right to receive the grant, and it is probable that the economic benefits comprising the grant will flow to the Entity and the amount of the grant can be reliably measured.

When the grant relates to a specific period it is recognised as income of that period. If a grant is received prior to the specific period it is credited to a deferred income account until the commencement of the specific period.

When the grant relates to an asset, the fair value is credited to a deferred income account and is released to the income statement over the expected useful life of the relevant asset by equal annual incstalments.

Interest revenue

Interest revenue is recognised on a proportional basisi taking into account interest rates applicable to the financial asset.

Cash and Cash Equivalents

Cash and short term deposits in the balance sheet comprise cash at bank na d in hand and short term deposits with an original maturity of three months or less, For the purpose of the Statement of Cash Flows, cash and cash equivalenys consists of the above.

Plant and Equipment

Plant and Equipment are carried at cost less, where applicable, any accumulated depreciation. The carrying amount of plant and equipment is reviewed annually by the board so as to ensure that it does not exceed recoverable amount.

The depreciable amount of all fixed assets are depreciated on a Diminishing Value basis over the useful lives of the assets in the association commencing from the time the assets are held ready for use.

Employee Leave Provisions

Provision is made for the Entity's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled, plus related on-costs. Employee benefits payable later than one year have been measured at the presnt value of the estimated future cash flows to be made for those benefits.

Contributions made by the Association to employee superannuation funds are charged as expenses when incurred.

Long service leave entitlements are recognised once an employee had completed five years of service.

Goods and Service Tax (GST)

Revenue, expenses and assets are recognised net of the amount of associated GST, unless the amount is not recoverable from the tax authority. In this case it is recognised as part of the cost of the acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivables or payable. The net amount of GST recoverable from , or payable to , the tax authority is included in other receivables or other payables in the statement of financial position.

Cash Flows are persented on a gross basis. The GST components of cash flows arising from investing or financing actovities which are recoverable from or apyable to the tax athority, are presented as operating cash flows.

Commitments and contingencies are disclosed net of the ampount of GST recoverable, or payable, to the tax authority.

Income Tax

Under section 50.10 of the Income Tax Assessment Act 1997, the association is exempt from income tax.

Critical Accounting Judgements, Estimates and Assumptioms

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historacal experience and other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgemnts and estimates will seldom equal the the actual results. The judgements, estimates and assumptions that have a significant risk of causing material adjustment to the carrying amount of assets and liabilities (refer to the respective notes) within the next financial year are disclosed below.

Estimates of useful lives of assets

The entity determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment and finite life of intangible assets. The useful lives could change significantly as a result of technical innovations or some other event. The depreciation and amortisation charge will increase where the useful lives are less than the perviously estomated lives, or technically obsolete or non-strategic asset that have been abandoned or sold will be written off or written down.

Employee benefits provision

As discussed in note 1, the liability for employee benefits expected to be more than 12 months from the reporting date are recognised and measured at the present value of the estimated future cash flows to be made in respect of all employees at the reporting date. In detrmining the present value of the liability, estimates of the attrition rates and pay increases through promotion or inflation have been taken into account.

Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

Going Concern

The financial report has been prepared on a going concern basis as the board have been assured of continued finacial support from grant funding organisations and the board believes such support will continue to be made available to the association.
