We are a not for profit membership organisation, incorporated under the Associations Incorporation Act (SA), and governed by a Board of Management, in accordance with its Rules, and delegates the daily operations of the organisation to a CEO.

Writers SA generates income through membership fees, ticket sales, project and fee for service activities and we are supported for our core activities through multi-year funding from the Government of South Australia via Arts South Australia.

Writers SA has also been the recipient of grants from Australia Council for the Arts (from August 2023 known as Creative Australia), Office for the Arts, Copyright Agency, Green Adelaide Grassroots and is in partnership with the State Library of South Australia and City of Adelaide Libraries to deliver workshops, opportunities and events.

We have a reputation for ambition and excellence, reflected in our work in community engagement and audience development, and our commitment to high calibre programming and practices.

Throughout this period of transition, we have been fortunate to be supported by the steady hands of Tamara Montana and Vern Schulz, and our dedicated board members Nick Hays, Rachel Spencer, David Meldrum, Jane Howard, Mia Formichella, and Truphena Mahindu. I am especially grateful to my fellow board members, who have gone above and beyond in their voluntary service—particularly during the difficult period following the early resignation of Director Laura Kroetsch in early 2025 due to ill health. Laura's leadership was deeply valued, and her departure was felt across the organisation.

In 2024, we also laid the foundations for our next strategic plan under the guidance of Interim CEO Rainer Jozeps. We're energised by a renewed vision: to place writing at the centre of life in South Australia and to connect readers and writers across a broader literary community.

We remain deeply appreciative of the ongoing support from the Hon Andrea Michaels MP, Arts SA, Creative Australia, the State Library of South Australia, Copyright Agency, the Art Gallery of South Australia, the City of Adelaide, and our valued collaboration with Flinders University, the University of South Australia, and the University of Adelaide on the publication of *Splinter*.

We look forward to continuing these vital partnerships and delivering meaningful outcomes for readers and writers across the state.

From the interim-CEO

In 2024, Writers SA delivered its vision to place South Australian writers and writing at the forefront of Australian literary culture. Before the then-Director Laura Kroetsch stepped down due to health concerns, she had begun steering the organisation in 2024 toward a broader vision celebrating the act of reading as well as writing; reading and writing being two sides of the one coin.

A search for the next Director is scheduled to commence in the middle of 2025.

2024 was bustling with a broad range of activities including literary writing fellowships, story pitching workshops, as well as a range of literary prizes presented in association with numerous partners.

The year saw a number of staff shift their attention to other professional opportunities and, along with my temporary role as interim CEO, at the time of preparing this report, there is renewed energy and optimism among a new and highly experienced staff pursuing existing and new programs and projects in support of our vision.

Our membership revenue, while slightly dipping from the previous year, is enjoying a 14% increase since 2022, while income from grants, donations and philanthropy were up by 48% from the previous year. This increase in income was spent on a significant increase in program activity.

As in life, not everything went to plan in 2024. Financial ill-winds buffeted our operations as staff changes, rent and office cost over-runs put pressure on our finances.

We continue to be indebted to our funding supporters acknowledged elsewhere in this report. This includes the State Library of South Australia who provide Writers SA with a home in the historic Institute Building, a wonderful 19th century structure that began its life as a place for the citizens of Adelaide to read.

MEMBERSHIP Total number of members: 658 total, 433 full members, 221 concession members, 4 writing groups

MEMBER SERVICES: Writers SA offers writers access to a professional, independent reading and assessment service. All our assessors are industry professionals, with many years' experience in reading, assessing, reviewing, representing and publishing manuscripts. In 2024, we undertook 4 x pre-submission packages, 17 x first feedbacks (paid and program credits) and 32 x manuscript assessments. We paid \$16850.00 to assessors who are authors and/or editors.

Consultations: We offer complimentary advisory consultations for members who have writing, publishing and creative career queries. These meetings can be conducted in person, over the phone, or video conference, and are a special members-only resource. Full, paid consultations are also available to both members and non- members at tiered prices, with a discount for members. In 2024, there were 42 consults both paid and free.

Mentorships: The Writers SA mentorship program is designed to connect our members with a suitable, formal mentor, at any stage of their writing careers. From writing craft, editing and pre-publication, to marketing and publicity mentorships – and encompassing a wide range of genres – Writers SA assists early-career writers to find the mentor to guide their creativity to the next level. In 2024, we delivered 2 x mentorships.

PROGRAM Writers SA offer a year-round program of literary workshops, events and longer term programs. Our 2024 program served a diverse community of writers, with participants in SA, interstate and even overseas. Our workshop program was delivered both in person and online, featuring acclaimed writers like Ali Griffin Vingiano and Sophie Mackintosh, a free and exclusive panel with publishing experts, a nature writing intensive hosted at the Adelaide Zoo, a masterclass with Andy Griffiths and much more.

Over 40 authors, agents, publishers, and speakers delivered 50+ workshops and talks, and 5 long-term programs over the year. We programmed and delivered Adelaide Writers' Week masterclasses, and a number of free events both for Writers SA and partners.

Literary Sector Development

Writers SA continued to develop a diverse and flourishing literary community through our work with targeted groups. Through our advocacy and artist capacity building projects, we provide skills-based and community-led programs to create connections, pathways to industry, interstate collaboration and introductions, and new literary works.

ADELAIDE WRITERS' WEEK

We partnered with Adelaide Writers' Week to co-present 3 sessions in 2024.

Writing Relationships: Authors & Their Editors Join Madison Godfrey, Kate Grenville and Anjum Hasan for an intimate exploration of the other great partnership in life – the author-editor relationship – that takes writing from the deeply personal to the public stage, with Jessica Alice.

Ask Me Anything: Book Publishing 101 From bidding wars to MFA wunderkinds, publishers see it all. Go behind the scenes with Miranda France, Vanessa Radnidge and Jeanne Ryckmans to answer all your curly questions about the world of writing and publishing, with Jessica Alice.

Going Gonzo: Immersive Research From reporting on the far right to journeys in the Paraguay jungle, join award-winning journalists Royce Kurmelovs, Tory Shepherd and Ben Stubbs for a deep dive into the risks and rewards of immersive storytelling, with Smriti Daniel.

WRITING WEDNESDAY

A free, volunteer-led weekly session every Wednesday for members. The program uses the Pomodoro Technique of four sessions of 25-minutes with a five-minute break between each. The method trains the mind to effectively reach smaller targets, improving your overall writing time and productivity.

THINK TANK

In partnership with City of Adelaide's City Library, a co-writing session held on the fourth Wednesday of each month. It provides an informal space to discuss concepts, test plotlines, workshop a synopsis, and brainstorm and get feedback on your ideas in this fast-paced hour of creative construction.

TEEN WRITERS CLUB

The Teen Writers Club is a place for high school aged writers to make new connections, be inspired, and develop their writing. It provides a safe, fun and engaging program for passionate young writers of all interests, ages and abilities.

SPLINTER JOURNAL

The launch of *Splinter's* inaugural issue in November 2024 represented a coming-together of diverse communities of writers, readers, and partners.

Splinter is created through a rare collaborative partnership between Writers SA and the three major South Australian universities – Flinders University, the University of Adelaide, and UniSA. It is supported by CreateSA. These partners recognised the need for a national literary journal made out of Tarntanya, which could help SA writers bridge the gap between our smaller city and the wider literary industry.

In its first issue, *Splinter* published 25 writers, putting emerging and established South Australian authors on the page alongside a list of national and international names. Attracting readers from around Australia and around the world, the journal – although young – is already helping new audiences experience the quality and depth of South Australian writing via a non-parochial, high-quality publication.

As well as creating new pathways to publication, *Splinter's* first issue offered skills development opportunities. In producing the first issue, we worked with an editorial committee of eleven emerging to mid-career South Australian writers and editors. Hailing from the three universities and the wider writing community, these committee members gained real-world literary industry experience as they assessed submissions, edited pieces for publication, and proofread the journal.

The response of writers and readers to *Splinter* has been heartening. Hundreds of high-quality submissions poured in during our inaugural submissions callout. Ten established South Australian writers stepped up to form our strategic advisory committee. More than 75 per cent of our issue one print run has sold, with two months of the sale cycle still to go. And our issue one launch, which included live readings from three of the published writers, was attended by more than 100 warm and enthusiastic supporters.

With issues two and three due out in May and November 2025 respectively, we're excited to see *Splinter* continue to grow.

PRIZES, AWARDS, FELLOWSHIPS

SA LITERARY FELLOWSHIPS PROGRAM Writers SA and the State Library of South Australia partnered to offer the second year of the SA Literary Fellowships program to support emerging, established, and First Nations writers. With investment from Creative Australia (Australia Council for the Arts), Arts South Australia and the Libraries Board of South Australia, the program offered five annual creative writing fellowships with a cash component, desk space, and access to the Library's collections. Open to all writers living in South Australia to encourage the original and imaginative use of the Library's spaces and collections to develop new literary works, the program was developed in direct response to the needs of the local literary sector, addressing a gap in South Australia's current fellowship and prize opportunities. Through the awarding of Fellowships and the presentation of a series of public events, this program aims to grow audiences of readers, promote libraries and literature, and further the development of South Australian authors. The fellowships were awarded to Kate Marie Lewis, Jennifer Mills, Helen Edwards, Piri Eddy and Alexis West.

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The members of the board have prepared the financial statements on the basis that the Entity is non-reporting because there are no users dependent on a general purpose financial report. The financial report is therefore a special purpose financial report that has been prepared in order to meet the requirements of the Associations Incorporation Act 1995 and the Australian Charities and Not-for-Profits Commission Act 2012.

The financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and and interpretations and disclosure requirements of the following standards:

AASB 101	Presentation of Financial Statements
AASB 107	Statement of Cash Flows

The financial Statements have been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following material accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

Revenue Recognition

Revenue is recognised to the extent that it is probable that the economic benefit will flow to the Entity and the revenue can be reliably measured. The following specific recognition criteria must also be met before revenue is recognised:

Grant Revenue

Revenue from grant funding is recognised when the Entity gains control of the grant or the right to receive the grant, and it is probable that the economic benefits comprising the grant will flow to the Entity and the amount of the grant can be reliably measured.

When the grant relates to a specific period it is recognised as income of that period. If a grant is received prior to the specific period it is credited to a deferred income account until the commencement of the specific period.

When the grant relates to an asset, the fair value is credited to a deferred income account and is released to the income statement over the expected useful life of the relevant asset by equal annual instalments.

Interest revenue

Interest revenue is recognised on a proportional basis taking into account interest rates applicable to the financial asset.

Cash and Cash Equivalents

Cash and short term deposits in the balance sheet comprise cash at bank and in hand and short term deposits with an original maturity of three months or less, For the purpose of the Statement of Cash Flows, cash and cash equivalents consists of the above.

Plant and Equipment

Plant and Equipment are carried at cost less, where applicable, any accumulated depreciation. The carrying amount of plant and equipment is reviewed annually by the board so as to ensure that it does not exceed recoverable amount.

The depreciable amount of all fixed assets are depreciated on a Diminishing Value basis over the useful lives of the assets in the association commencing from the time the assets are held ready for use.

Employee Leave Provisions

Provision is made for the Entity's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled, plus related on-costs. Employee benefits payable later than one year have been measured at the present value of the estimated future cash flows to be made for those benefits.

Contributions made by the Association to employee superannuation funds are charged as expenses when incurred.

Long service leave entitlements are recognised once an employee has completed five years of service.
